As you know Carl, the check will only be a partial month running through Sept. 23rd. dice sales.



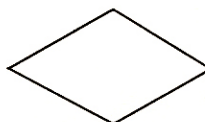

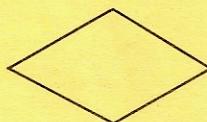
